From the Head

I have attended the Association of Pathology Chairs Annual Meeting for the past four summers. Three Canadian Chairs participated last year; this year I was alone. Why don't other Canadians regularly attend? After all, the meeting has an annual focus on either undergraduate medical education, graduate education, and the business of pathology departments, issues of interest to all of us.

Is it because our health care systems are so different? Are lessons learned in one irrelevant to the other? Or are we distinct from other Canadian departments? We are a broad based department of laboratory medicine which incorporates an active graduate and residency program and basic research. We are collegial, cooperative, and communitarian with departmental discretionary funds that allow flexibility and creativity. Many United States departments can be similarly described. Other Canadian schools cannot. Irrespective, the lessons of US departments of pathology have relevance for all of us in Canada. Research funding, both operational and personnel support, is becoming increasingly competitive and the ability to fund academic and research activities from a service base is diminishing rapidly. Managed care in the United States induces responses extraordinarily similar to both our Alternate Funding Plan and regionalisation of laboratory services. Both combine reduced funding with a Faculty wide review of departmental resources which inevitably focus on faculty numbers and income.

All departments are now being asked to demonstrate the "value" they add to clinical care, health or wellness, and to the academic

mission. And these demands are likely to become increasingly explicit. The values perceived will be transmuted into the cash received.

Researchers are used to these peer judgements. In our department they have done extraordinarily well. We have five faculty on external salary support combined with over 2.5 million dollars of annual operational research support. These researchers recognize the fragility of this funding and the necessity to focus the majority of their time on their research. Of the 31 members of the department, 11 have 75% of their time assigned to research and related graduate education. The value they add and their performance has to meet the standards of internationally peer reviewed journals and grant panels.

The challenge for the 20 of us not predominantly involved in research is to demonstrate our value as clearly and to a similarly high standard as our 11 research intense colleagues. Within the next few months we should begin to benefit from our reorganization. We will have one laboratory, predominantly on one site, and with a correspondingly simpler administrative structure and fewer meetings. This is the time to heighten our collective scholarly expectations and focus them through individuals on clinical, collaborative and health services research, and on educational initiatives with resultant publications. I will be discussing this further with each of the clinical divisions of the department over the next months. What are your personal expectations? those of your division(s)? What can the department do to facilitate them?

WHY THE OMBUDSPERSON?

I am sure that most of us find Pathology a very happy place to work partly because the Department has encouraged policies that make for a pleasant workplace. Many of these initiatives have been seamlessly integrated into the culture of the Department, and are taken for granted.

One initiative strongly supported by Dr Manley was the creation of the position of Ombudsperson. Although the University has a Human Rights Office which advises and supports Faculty and Students and other employees, (both complainants and respondents), in matters which concern possible contraventions of the Human Rights Act and the University Human Rights Policy, the Departmental Ombudsperson is a useful adjunct who may by education, and by early intervention on some occasions, prevent serious difficulties from occurring

Almost all Human Rights cases seen at the University Office arrive there after a great deal of anguish on the part of the complainant, and it is likely that many valid complaints are never presented. Almost all Human Rights complaints arise out of imbalances of power; for instance situations where the behaviour of a supervisor is harassing to a subordinate, and most of these involve sexual harassment. Definitions of discrimination and harassment are clearly laid out in the Senate Policy of June 1995 (available from the Department Office), and space does not allow for re-iteration of them here.

It may seem surprising in the nineties, given the extensive publicity, that sexual harassment is still a problem. Many people are simply still not aware that some behaviours are not acceptable. Harassment does not necessarily imply an intent on the part of a harasser to discomfort or harm the harassed, and is

often perceived as friendly or humorous behaviour, though in the more serious forms it constitutes a deliberate and demeaning abuse of power.

Imbalances of power are found in all workplaces and ours is no exception. From time to time individuals who are experiencing problems may need to seek advice. The Ombudsperson can give confidential help to any person who feels that they have a problem, by offering information about policies and procedures, informal intervention in some instances and providing moral support whilst the problem is resolved.

An Ombudsperson can only help if asked. I hope that all of you will feel free to talk to me about harassment, if you think you are being harassed, or you think that you might have done something that might be construed as harassing.

PART/T Committee

The PART/T Committee has completed its first full cycle of activities with the end of Samuel Ludwin's term as Chair for the last three years. Advice, judgement and advocacy have been the major roles of the Committee and these have been fulfilled with thoroughness, thoughtfulness and courtesy through the guidance of Sam.

The terms of reference of the Committee were developed by Alan Giles and Alessandra Duncan. According to these terms, the new Chair had to have prior experience on the Committee and to be chosen by the members. Iain Young, who has served as Chair of the Departmental Strategic Planning Committee and is the current Chair of Anatomic Pathology was chosen by the Committee members for a three year term to end in June 1999.



Reflections on a long and busy summer:

The summer of 1996 has been a very different one. The usual planned inactivity was instituted taking advantage of the natural downturn of the summer months. Reduced OR activity and lowered bed counts still kept people busy as their reduced complements allowed for much-needed vacation breaks by their colleagues.

During this time however, senior representatives of the hospitals have been wrestling with the difficulties of meeting both current and anticipated budget and healthcare resource allocations. Clearly the current structures and functions cannot continue to be properly supported in the absence of dollars. This has led to a radical plan of restructuring patient-care delivery across the city. The plan requires approval by a number of bodies and has to satisfy the Provincial Restructuring Committee. These planned changes will be a major challenge and require commitment, cooperation and continuance to ensure the delivery of

patient-care in the new environment of the single virtual hospital. The entire system of healthcare will be impacted from patient entry to discharge providing the opportunity for innovative approaches in patient care, including support services, particularly in the Ambulatory-Care setting. So by no means has it been a quiet summer of partial aestivation.

Summer activities:



If you have access to the Queen's Library Index program on your computer (QWS3270 or Telnet to Queen's Library Index) start it up and choose **QCAT** from the main menu. You will be doing a title search so enter **t=the complete title of the journal** no quotes commas or anything else. If it is listed you will see a result with the word SERIAL or SER. Choose that entry (usually 1). The next result should say Health Sciences Library and over on the right it should tell you to issue the command **HOL 1** for holdings. You will get a result that looks like this:
