



**ACADEMIC ANATOMICAL PATHOLOGIST**

The Department of Pathology and Molecular Medicine in the Queen's University Faculty of Health Sciences is recruiting an academic Anatomical Pathologist with diagnostic expertise in dermatopathology and with the ability to participate in other diagnostic pathology subspecialties, particularly nephropathology. The ability to contribute to autopsy pathology would be considered an asset.

We are a very collegial department with a strong culture of scholarship. The successful candidate will provide evidence of an ability to work in an interdisciplinary, collaborative environment and will also demonstrate strong potential for and/or experience in innovative and scholarly research. Applicants should demonstrate strong potential for outstanding teaching contributions in the department's undergraduate, graduate and residency training programs. There is potential for flexibility in the balance of service and academic time commitments for these positions. The compensation package is very competitive.

Candidates must be eligible for medical licensure with the College of Physicians and Surgeons of Ontario and must hold postgraduate qualifications in Pathology. This is an international search and the University invites applications from all qualified individuals. However, preference will be given to applicants who hold certification from the Royal College of Physicians & Surgeons of Canada or the American Board of Medical Specialties. Appointment will be at an academic rank commensurate with experience.

Evaluation of applications will begin immediately and will continue until the position is filled, with an anticipated start date of May 2019.
